**ELECTRONIC WAREHOUSE RECEIPTS FEE
GUIDELINES**

GENERAL PRINCIPLES

Within the scope of Article 12 of the Electronic Warehouse Receipt Regulation and Article 25 of the Electronic Registration Rules issued pursuant to the said Regulation, the Electronic Warehouse Receipt Fee Tariff has been approved by the Ministry of Trade, General Directorate of Domestic Trade as of 19/12/2025.

1. Fees are charged monthly on member basis and collected until the 15th day of the following month. Safekeeping fees are assessed on daily account balances and charged monthly.
2. Fees do not include VAT (Value Added Tax).
3. As it is stipulated in the Article No:6 of MKK Membership Agreement, if there is a joint undertaking letter signed between MKK members, the assigner (delegating member) is charged accordingly.
4. For commission refunds to be made for any reason, the relevant member must issue an invoice for the same amount of the service.
5. If the commission fee calculated on a transaction basis is below 10 cents (excluding VAT), no invoice will be issued.

1. MEMBERSHIP FEES

Membership Fee	TRY 366.299	1. Membership fee is collected monthly from the members throughout the membership period. Branch membership fee is applied as TRY 244.199 for all branches of licensed warehouses other than one branch. (Number of branches x TRY 244.199) 2. Membership fees are not collected from authorized classifier type members.

• **ISSUANCE, CANCELLATION AND CUSTODY SERVICES**

Licensed Warehouse	Process (Issuance, Cancellation)	TRY 6.1320	1. Issuance and cancellation are applied on a transaction basis, regardless of the amount. 2. The custody fee refers to the daily (calendar day) fee for 1 ELUS. It is calculated on a daily basis relevant investment institutions/Product Market Intermediary Institutions / TMEX Commodity Market Intermediary Institution (UPAK) and accrued monthly on a member basis. For example, if the number of days of custody is 28; (custody balance is calculated as 0.000003907192449 *28.)

For the EKK memberships of the relevant institutions; membership fee (starting from the date of membership), investor account opening and investor information transaction fees are applied within the scope of the MKK Fee Tariff.
